**IS YOUR RESIDENT "SAD" OR CLINICALLY DEPRESSED?**

**JANICE FUNK, PHD**, clinical neuropsychologist has been brought back by popular demand! Funk will talk about late-life-depression being the single most commonly treated mental disorder. Funk's presentation will explore how current diagnostic criteria may inflate the numbers of individuals diagnosed with clinical depression leading to overtreatment with antidepressant medications, especially in the elderly.
